Action Requested: Review guidelines and implement immediately

Brief Explanation:

This protocol has been established to help graduate students who transfer into San Diego Unified School District from out-of-district, out-of-state or out-of-country by ensuring the work completed in the area of science is transferable and meets SDUSD district's science graduation requirements.

Students transferring to the district who have completed a science course outside of the current *Course of Study, TK-12* and earning a grade of "D" or higher in any grade 9-12 will be awarded science credit according to the following guidelines:

As referenced in Administrative Procedure 4770, Integrated Science 1-6 will meet the following district science course sequence:

Out of District Course	SDUSD Science Graduation Equivalent
Integrated Science 1, 2	Biology 1,2
Integrated Science 3, 4	Chemistry 1,2
Integrated Science 5, 6	Physics 1,2

When transcribing an "Integrated Science," registrars should continue to use course numbers 6498 & 6499, and change title to reflect the course level as noted above (*using all CAPS*).

When students enroll with us from out-of-country where a science European model is used (i.e. student takes all three sciences, Biology, Chemistry and Physics, all three years of high school), registrars will transcribe as follows:

European Science Model	SDUSD Science Graduation Equivalent (Use district science course numbers for courses below)
Year 1 (9 th)	Biology 1,2 (6111, 6112)
Year 2 (10 th)	Chemistry 1,2 (6211, 6212)
Year 3 (11 th)	Physics 1,2 (6311, 6312)

When students enroll with us from out-of-district/state with the following courses:

- Environmental Science 1, 2
- Astronomy 1,2
- Agriculture 1, 2
- Anatomy 1, 2
- Genetics 1,2
- Zoology 1, 2
- Etc.

Registrars must:

- 1) Verify out-of-district school's UC a-g list to determine if the course meets the site's life or physical science, and transcribe accordingly (use course numbers 6498, 6499).
- 2) Request course description to determine if the course aligns with any SDUSD course within the *Course of Study, TK-12*, then transcribe accordingly.
 - a) If the course does not align with any of our district courses, generic elective course number 6000 should be used.

Please also refer to Administrative Procedure 4771, for a list of alternative means science courses that meet SDUSD graduation requirements.

NOTE: Generic course number 6000 Science should still be used when transcribing generic entry level science courses, and will count as elective credit only.
