Introduction

At the end of each year a report is prepared using voluntary survey input from prime contractors, subcontractors and DVBE suppliers who were awarded San Diego Unified School District construction contracts during that year. "Awarded a contract" refers to a company that has completed, is currently working on, or will begin working on a project that was awarded by San Diego Unified's Board of Education between January and December.

The primary goal of the Annual Contractor Survey is to assess the makeup of San Diego Unified's capital improvement bond program contractor pool in a manner that goes beyond the EBE categories tracked as part of the business outreach and engagement program. The findings provide another avenue for gauging contractor recruitment efforts and steering program improvement.

Background

The 2011 Annual Contractor Survey was conducted via SurveyMonkey and telephone. While data was considered difficult to obtain, 91 of 104 targeted contractors ultimately provided input. A mandatory, hardcopy survey that would ensure 100 percent survey participation was recommended for rollout the following year.

The 2012 survey was conducted via a paper survey included in the existing mandatory Project Stabilization Agreement (PSA) paperwork packet. Although provided to all general contractors and subcontractors throughout the year, only 23 surveys were received by late October 2012, and significant telephone interviews were required to obtain input. In all, only 49 surveys were collected.

By comparison, the original SurveyMonkey survey was highly successful and was reinstated for the 2013 survey. In addition, in 2013, a more complete audit of PSA subcontractors was conducted and a list of 632 contractor contacts was provided to the Business Outreach team (it should be noted that this list included multiple contacts from each company).

In June 2013, a formal demographic assessment (*Demographic Analysis of the Ownership and Workforce of Construction Firms in San Diego County*) was commissioned by a third-party non-profit organization to examine census and demographic data of San Diego construction industry business ownership. Information collected in this 2013 Annual Contractor Survey was broadly compared to the information in the *Demographic Analysis*.

Results

The SurveyMonkey data for the 2013 contractor survey are presented in the attached addendum. In total, 96 contractors responded to the survey, 10 were eliminated after Question 1 for not having an active contract in 2013. An additional 16 did not fully complete the survey. Not all of the applicable questions were answered by participants. In general, the data reflects what was expected by the Outreach Team: most companies were small, male-owned and one-third did not hold any emerging business certifications.

New questions and new elements to existing questions were added to this year's survey that generated interesting information. When asked, subcontractors provided names of their

general contractors, some of which were not in the business outreach database or known to be bidding San Diego Unified projects. This provides new avenues for outreach, and follow-up will be conducted in 2014. Of note, eight subcontractors indicated that their surety bond was held by the general contractor.

Conclusion

Participation in the 2013 Annual Contractor Survey was similar to that of the 2011 SurveyMonkey survey and far better than that of the 2012 hardcopy version. SurveyMonkey will continue to be used to collect end of year contractor data.

In conclusion, the results of this survey held no major surprises and generally reflect the findings of the 2013 independent San Diego construction industry *Demographic Analysis*. Based on the data, outreach efforts are being conducted in an appropriate manner. No direct changes to the business outreach and engagement program are needed or will be made as a result.






