



Your Paycheck/Direct Deposit Advice

Your paycheck is printed on a fold and seal mailer. This ensures that your personal information remains confidential. If you have questions regarding your paycheck information, please contact your Payroll Specialist.

Employee ID

The number listed is your Employee ID in the Human Resources system. Your site's number and name are listed here. Your Location represents the payroll distribution area where your check and/or advice will be delivered. Your Job Title is listed here, as well as your Salary Plan, Grade and Step.

Employee Information

This block contains your name and mailing address.

Hours and Earnings

This shows current and year-to-date earnings. All earnings are listed here, e.g., Regular, Overtime, etc.

Before-Tax Deductions

The items listed here are deducted from your gross pay, before taxes are calculated.

Totals

This row lists your current and year-to-date Total Gross (total earnings before any deductions or withholdings), Federal Taxable Gross (total earnings minus before-tax deductions), Total Taxes (total taxes withheld), Total Deductions (total deductions taken), and Net Pay (your earnings after deductions and withholdings).

Leave Banks

This area lists your leave balances.

This will only be printed on Direct Deposit advices.

Your mailing address

Your location code representing the payroll distribution area where your check will be delivered, followed by your advice number, followed by your Pay Run ID, which is your pay date followed by an S for Salaried or an H for Hourly.

Pay Period

These are the pay period begin and end dates.

Paycheck/Direct Deposit Advice # and Check Date

This number is a reference number for your paycheck/direct deposit advice. The check date is the pay date.

Tax Data

Your Federal and California tax withholding status are listed here. If you withhold an additional percentage or amount, that status will be listed here. Any additional amounts are also listed here.

Taxes

Your current and year-to-date withholdings for Federal and California taxes are reflected here, as well as FICA and Medicare.

Message

Check this area for any important messages from San Diego City Schools.

After-Tax Deductions

Any additional items withheld from your pay, such as union dues and additional insurance are listed here. These items are deducted after your tax withholdings are calculated.

Net Pay Distribution

For Direct Deposit, this area shows how much was credited to your bank or credit union account(s). If you do not participate in Direct Deposit, this is the amount of your actual paycheck.

Direct Deposit Distribution

This block lists the account(s) that was credited with your earnings. Your account type (checking or savings), your account number and the total deposit amount are reflected.
